WHEREAS, the Board and Union are parties to a collective negotiations agreement governing the terms and conditions of employment for all regularly employed non-teaching certificated employees of the South Bergen Jointure Commission (hereinafter referred to as "Outreach Employees") for the period beginning July 1, 2022 and ending June 30, 2025 (hereinafter referred to as the "Agreement");
